2. What is the procedure followed by the Controller while appropriate legal action when a sample is detected to be of 'Not of Standard Quality'. Does the Controller initiate criminal prosecution in all cases or is suspension of license enough. The PIO is requested to


**please provide the applicant with a copy of procedure/rules to be followed while deciding appropriate legal action in such cases.**
