IV. BRIEF FACTS OF CASE :

1. The Complainant K.Dass Drugs Inspector Machilipatnam (Lw1) respectfully submits that he is a Drugs Inspector appointed U/s 21 of the Drugs & Cosmetics Act 1940 having jurisdiction for the entire state of Andhra Pradesh and is authorized to launch this prosecution U/s 32 of the said Act. Sri. DBMK Chakravarthi (Lw2) is also the Drugs Inspector appointed U/s 21 of the Drugs & Cosmetics Act 1940.
2. On 23.2.2010 during joint raids conducted at Machilipatnam under the supervision of the Deputy Director Eluru range and Asst Director Krishna District Mr. S. Vijaya Kumar (Lw7). , As per the directions of the Deputy Director K.Dass Drugs Inspector Machilipatnam (Lw1) along with Mr. DBMK Chakravorthy Drugs Inspector Vijayawada zone 1 (Lw2) proceeded to M./s Sri Venkata Ramana Medical and fancy stores at Sri saran shopping complex shop no. 12 Laxmi talkies centre Machilipatnam which is a Licensed firm under Form 20 & 21 to sell drugs.
