- 7. After completion of the Inspection at M/s Venkata ramana Medical & Fancy stores Machilipatnam at 6.55 pm on 23.2.2010 Mr Venkata Ramana voluntarily agreed to come to Vijayawada to identify Mr. Ramesh.
- 8. As per the telephonic instructions of the Asst. Director DCA Krishna Mr. S. Vijaya Kumar (Lw7); K.Dass Drugs Inspector Machilipatnam (Lw1) along with Mr. DBMK Chakravarthy (Lw2); two local mediators Mr. Sadhu Prasad(Lw3) Mr. Ch. Durga Rao(Lw4); and Mr. Venkata Ramana (Accused A1) proceeded to M/s Akash Medical Agencies 11-13-20 sammetavari street Vijayawada. BV Laxman Rao (Lw5) was also present.
- 9. Mr. Venkata Ramana Accused A1 identified Mr. Ramesh (Accused A2), at m/s Akash Medical Agencies Vijayawada. On subsequent questioning of Mr Korikana venkat ramesh (Accused A2) s/o vishnumurthy resident of Door no 6-19-25 second floor Kotha pet Vijayawada; Accused A2 accepted the fact of selling the aforesaid drugs to Mr Venkata Ramana Accused A1 at M/s Venkata ramana Medicals Machilipatnam. Accused A2 Mr. Korikana Venkat ramesh further stated to have purchased the said products from Mr. Raghuram Accused A3 of Narsaraopet . Further the phone number 9246746718 was revealed as the phone number pertaining to Mr Raghuram (Accused A3) . (the said phone was found switched off) on further enquiry Mr. Korikana Venkat Ramesh Accused A2 was mum and did not reveal any other information when asked for. The identification parade and the questioning proceedings at M/s Akash Medical Agencies Vijayawada commenced at 9.00pm and concluded at 9.30.pm. Mediators report to this effect was drafted by Lw3 Mr. Sadhu Prasad.
- 10. As per the telephonic instructions of the Asst. Director DCA Krishna district Mr. Vijaya Kumar ( Lw7); K.Dass (Lw1) along with DBMK Chakravorthy (Lw2), and the Local Mediators Lw3 & Lw4; Mr. Korikana

Venkat ramesh Accused A2 and V Venkata Ramana Accused A1 proceeded to the residential flat situated in seetharamamma hall apartment of D NO. 6-19-25 and conducted search of the 4 rooms. No drugs / relevant documents were found available in the said premises. The search proceeding commenced at 10.00 pm and concluded at 10.30 pm. Mediators report was drafted to this effect.

11. On further telephonic instructions of the Asst. Director DCA Krishna Lw1 & Lw2 approached the I town Police station at Vijayawada. As it was 11.00pm, the Circle Inspector of police left the Police station and left message with the constables to meet on 24.2.2010.

- 12. One portion of the each drug as described in Form 18 were handed over to the Drugs Control Laboratory Drugs Control Admn Vijayawada on 24.2.2010 in person. Form 18's bear Memo no. 010210 & 020210 dt. 24.2.2010. Receipt of the said portions were acknowledged by the Drugs Control Laboratory Vijayawada
- 13. The drugs freezed vide form 15 were seized on 24.2.2010 and produced & Deposited in the Honourable II AJFCM Court Machilipatnam and CF NO.1984/2010 was allotted to the Form 16, Mediators report by the Honourable court.
- 14. The Asst Director DCA Krishna subsequently instructed to file complaint in the Chilkalpudi police station at Machilipatnam after conducting seizure of drugs which were freezed vide Form 15 dt. 23.2.2010.
- 15. The seizure information was submitted vide this office letter dt. 24.2.2010 to the Director General Drugs Control Admn. Hyderabad.
- 16. On 26.2.2010 as the Sub Inspector of Police Chilkalpudi, Mr. B Peddi Raju (Lw6) was available; based on the Instructions of the Director General Lw1 had submitted complaint in the police station duly providing the facts of the case and submitting the complete information. FIR

45/2010 was allotted and U/s 274 IPC, U/s 275 IPC & U/s 27 of the Drugs & Cosmetics Act the FIR was registered. The said information was submitted by fax to the o/o DG DCA Hyderabad.

- 17. The Asst. Director Mr. S. Vijaya Kumar (Lw7) served show cause notice on 26.2.2010 to M/s Venkata Ramana Medicals & fancy stores shop No. 12 Lakshmi Talkies center Machilipatnam.
- 18. The Asst. Director Mr. S. Vijaya Kumar ( Lw7) communicated the reply submitted by the firm and called for remarks from Lw1 K. Dass Drugs Inspector Machilipatnam. The reply submitted by Accused A1 was not found satisfactory, hence the same was submitted to the Asst. Director (Lw7) Krishna by Lw1. The Asst. Director (Lw7) cancelled the licenses of the firm vide dt. 29.4.2010 which was served on 4.5.2010 by Lw1.

- 19. Lw1 Mr. K.Dass Drugs Inspector Machilipatnam received Analytical report In Form 13 with regard to Glucored Forte tablets. The said drug was declared as Standard Quality.
- 20. Lw1 Mr. K.Dass Drugs Inspector Machilipatnam received Analytical report In Form 13 with regard to Primolut N tablets. The said drug was declared as Not of Standard Quality. (As Drug content was found to be NIL as against the declared label content of 5.0 mg/ tab, the Drug FALLS UNDER THE AMBIT OF DEFINITION "SPURIOUS" as according to Section 17 B (d) of the Drugs & Cosmetics Act 1940.
- 21. Subsequently duly providing copy of the Analytical reports as per the provisions of the Act; Notices with regard to the two drugs mentioned above U/s 18 A, 18 B & 22(1) (cca) of the Act were served once again on the Managing partner of the M/s Venkata Ramana Medical stores Mr. Venkata Ramana ( Accused A1 ). No subsequent replies were provided by the Managing Partner,.
- 22. Xerox Copies of Analytical Reports were provided to the Circle Inspector of Police Chilkalpudi as per their telephonic requisition.

- 23. As per the Partnership deed of the firm M/s Venkata Ramana medical stores Machilipatnam submitted during procuring the grant of license by the Licensee, the partners of the firm are V Venkata Ramana Managing Partner Accused A1 90% share, P Malathi Devi Lw8( Partner cum Pharmacist 5% share while M Rama Rao Lw 9 ( Partner cum building owner 5 % share).
- 24. Subsequently duly providing attested copies of the Analytical reports Notices were served on the partner cum pharmacist Mrs. P Malathi devi Lw8 of M/s Venkata Ramana Medical stores with regard to the two drugs mentioned above by Lw1. P Malathi Devi Lw 8 submitted her replies dt. 14.5.2010 stating that the Purchases of the Drugs were looked after by the Managing partner of the firm.

Subsequently duly providing attested copies of the Analytical reports Notices were served on Mr. M Rama rao Lw 9 Partner cum building owner of M/s Venkata Ramana Medical stores with regard to the two drugs mentioned above by Lw1. Mr. M Rama Rao Lw9 stated that he is the sleeping partner in the firm and that he is not responsible for the day to day activities of the firm.
- 26. Further notice was served on the Managing partner Accused A1 seeking clarification with regard to the version in his statement dt. 23.2.2010and reply provided by him on 21.5.2010. Reply from the Managing partner is not received in this regard.
- 27. Notices Dt. 31.12.2010 and one portion of each sampled drug were served in person by Lw1 Mr. K.Dass along with analytical reports to Mr. Korikana Venkata Ramesh ( Accused A2). Accused A2 submitted reply stating that he purchased the said Drugs from Mr. A Raghuram ( Accused A3).
- 28. Notices Dt. 29.1.2011 were served in person by Lw1 Mr. K.Dass along with copies of analytical reports to Mr. Raghuram (Accused A3). Accused

A3 submitted reply stating that the said Drugs have been sent by B Sree Hari Rakesh (Accused 4) to Mr. Ramesh (Accused A2).

- 29. Notices Dt. 28.5..2011 were sent by Registered post by Lw1 Mr. K.Dass along with copies of analytical reports to Mr. B Sree Hari Rakesh of Suma Sri Medical Coporation Kachiguda Hyderabad ( Accused A4). The said Registered Post was returned by postal authorities with instructions "Door Locked".
- 30. Notice u/s 18 B was sent to M/s Zydus Health care NH 31 A Majhitar Rangpo East Sikkim by Registered Post. On 8.4.2010 . Postal acknowledgment confirming the receipt of the said notice was received by Lw1 but no reply was received from M/s Zydus Health care NH 31 A Majhitar Rangpo East Sikkim.
- 31. Notice U/s 18 B was sent to M/s Sun Pharmaceutical Industries Survey number 259/15 Dadra 396191 by Lw1, the said notice was served on the firm. On the subject drug Glucored forte Printing of Both the addresses of Dadra and Jammu and Kashmir were made However in the indelible ink print it was printed as Mfg at Jammu. Therefore Notice U/s 18 B was also sent to M/s Sun Pharmaceutical Industries 6-9 EPIP Kartholi Bari Brahmana Jammu 181133 Jammu & Kashmir. Reply dt. 30.4.2010 was received from M/s Sun Pharmaceutical Industries Jammu. In reply, no matter was disclosed, while the enclosures of the Batch Manufacturing records of Glucored forte tablets Bno. AD90287, the Manufacturing date was printed as 1/2009 and expiry as 12/2011 while on the drugs seized from Accused A1, the Manufacturing date was 5/2009 exp. Dt 4/2012,

32. K. Dass (Lw1) requested the Director General Drugs Control Admn. to accord Permission to go to Jammu state for investigation at the manufacturing firm of M/s Sun Pharmaceutical Industries Jammu. K. Based on the Documents received by Lw1 from Lw8 and investigation at M/s Sun Pharmaceutical Industries 6-9 epip Kartholi Bari Brahmana Jammu 181133 by Lw1 it was evident that the labels of the said Glucored Forte tablets seized from Accused A1 bear the name of M/s Sun Pharmaceutical Industries 6-9 epip Kartholi Bari Brahmana Jammu 181133 to be the manufacturer of the drug, which the said company has not Manufactured and Sold. Whereby Accused A1 had contravened Section 18 (a) (i) r/w Sec 17 B (c) of the Drugs & Cosmetics Amendment Act 2008.

- 35. As Notices to Accused A4 were not served by Registered post, Lw1 on 23.6.2011 had personally served the Notices dt. 23.6.2011 with regard to the two Seized drugs. Investigation report was drafted on 23.6.2011 in the Presence of Accused A4 at M/s Suma Medical Corporation 3-4-1 Shop No. 21 PPS Commercial complex Station road Kachiguda Hyderabad. Subsequently, documents with regard to investigation of Drugs Inspector Uppal zone with regard to Glucored Forte tablets B No. Ad 90287 were provided by Accused A4 om 23.6.2011.
- 36. As Under the provisions of the Drugs & Cosmetics Act, the said complaint against the accused is being filed, the Sub Inspector of Police Chilkalpudi PS Machilipatnam Sri B Peddi Raju (Lw6) had sent the entire case file to Lw1 to take further action by the o/o Drugs Inspector Machilipatam.

Accused A1,A2, A3 & A4 had Violated Section 18(a)(i) r/w Section 17 B (c) & (d) of the Drugs & Cosmetics Act 1940 Punishable U/s 27 (c) of the said Act for Manufacturing & selling Spurious Drugs.

Accused A1 & A4 had Violated Section 18 A, 18 B of the Drugs & Cosmetics Amendment Act 2008 Punishable U/s 28; U/s 28 A respectively of the said Act for not disclosing the Name and address of the Persons from

whom the seized Spurious drugs were procured and for not keeping the Purchase documents pertaining to the seized Spurious Drugs.

In view of the facts stated above, the complainant request the Honorable Court to kindly consider the complaint and the Accused may be dealt as per Law.

It is further submitted that the said complaint is filed with in the period of limitation.
